Extension to Light Nelson Road Closure

1. Purpose of Report

1.1 To consider the extension of the road closure for Light Nelson.

2. Recommendation

That the Hearings Panel - Other

<u>Receives</u> the report Extension to Light Nelson Road Closure (R9517); and

<u>Approves</u> the application to extend the temporary Road Closure for Light Nelson until 3pm 11 July 2018.

2. Background

- 2.1 The Hearings Panel Other approved the road closure for Light Nelson on the 5 June this year between 5 July and 11 July. Event organisers of Light Nelson have requested that the road closure of Hardy Street be extended from 3am Wednesday 11 July 2018 until 3pm on Wednesday 11 July 2018. This request is due to wanting to avoid using noisy equipment required to remove lighting strung across the street, in the early hours of the morning. This will also increase the ability to remove other equipment from this site safely.
- 2.2 There will be negligible effect to residents or NMIT who do not currently have classes.

3. Conclusion

3.1 Council officers recommend that this application be approved.
