I would like to thank the Mayor for allowing me to address the issue of information given to this council at the last meeting.

Councillors were given information at the last meeting regarding workshops and what other councils do.

I wish to expand on that information and give some correction based on LGOIMA requests from councils around NZ last year. I apologise for not having them for you today there was a small technical fault, however admin does have the information and will no doubt inform you if I am incorrect. Information given to councillors at the last meeting was that if councils gave public notice of their Workshops it was just a generic statement in their council schedule.

However after I questioned this administration did confirm with Kapiti Council the following **“Open workshops are included in their public notices, so they are advertised in their local newspaper”** Kapiti out of interest has only 9 Workshops a year and all are open to the public.

Also Hutt City, publicises workshops and Clutha sometimes, admin report says they don't.

There are 5 other councils not included in admin report Taupo, Tauranga, Waipa, Westland & Manawatu who also publicise their Workshops and make them open to the residents and Rangitikei who say "Mostly no". Hauraki Council has open Workshops but not publicised.

At the 9th of Aug meeting Councillor Barker pointed out “we could be making policy about something that doesn't legally exist” and doesn't the idea of doing so much public business outside any legislative laws worry you, it worries me, and many others.

Cr Barker went on to say “And if we have a get together, briefing or whatever we call it we are not seen to be making a decision or close to a decision and the responsibility will rest on us to ensure we don't breach LGOIMA”

Well if you dont turn on the video I guess you won't be seen, as for " responsibility will rest on us to ensure we don't breach LGOIMA" sounds too much like " trust us" for my liking and I simply say "show us" because democracy is not based on trust, at its core is transparency and participation and by videoing all of the information provided, the residents can see that proper process is being followed, can be fully informed of the facts and participate in our local democracy as is everyone's right.

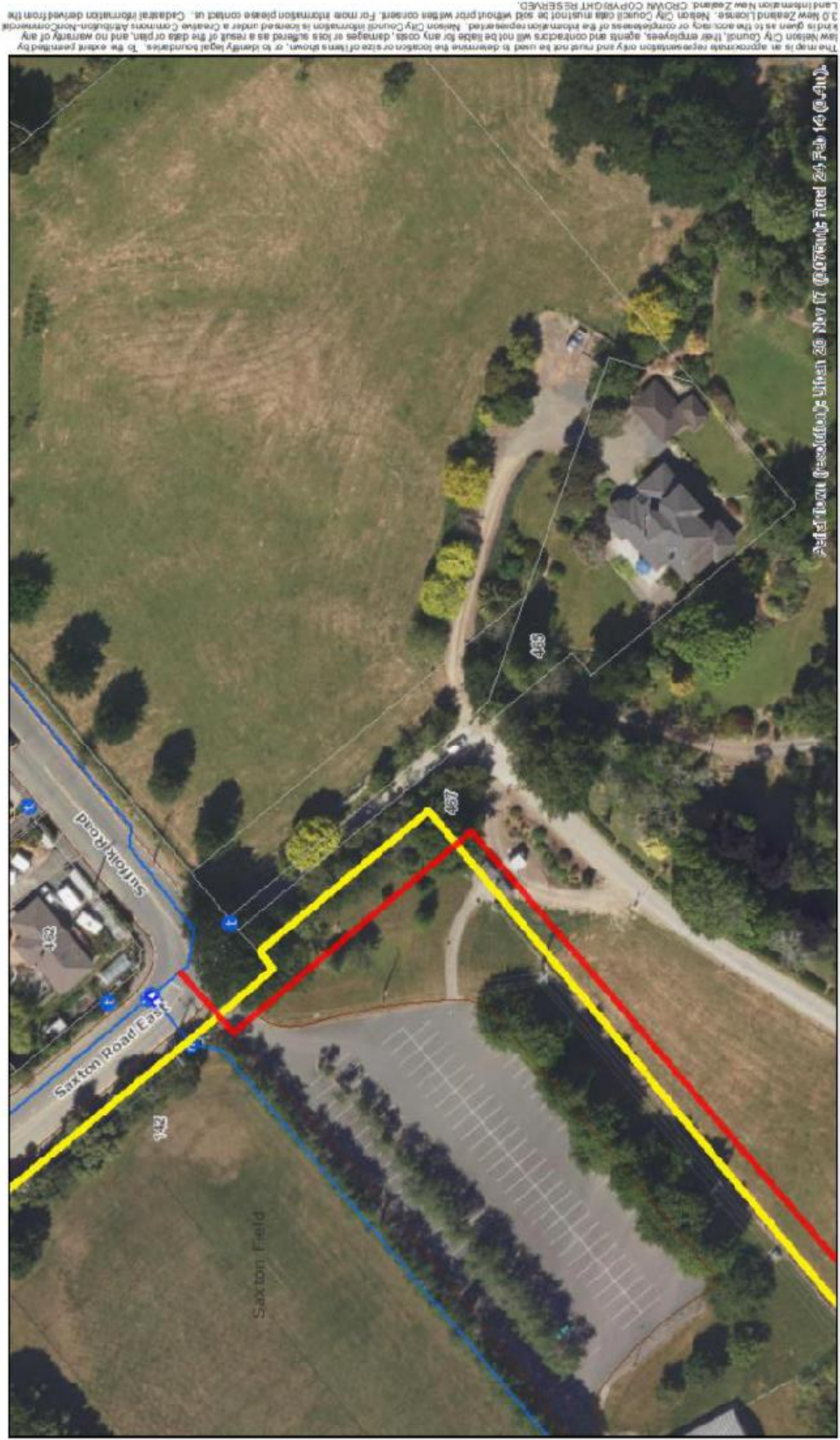

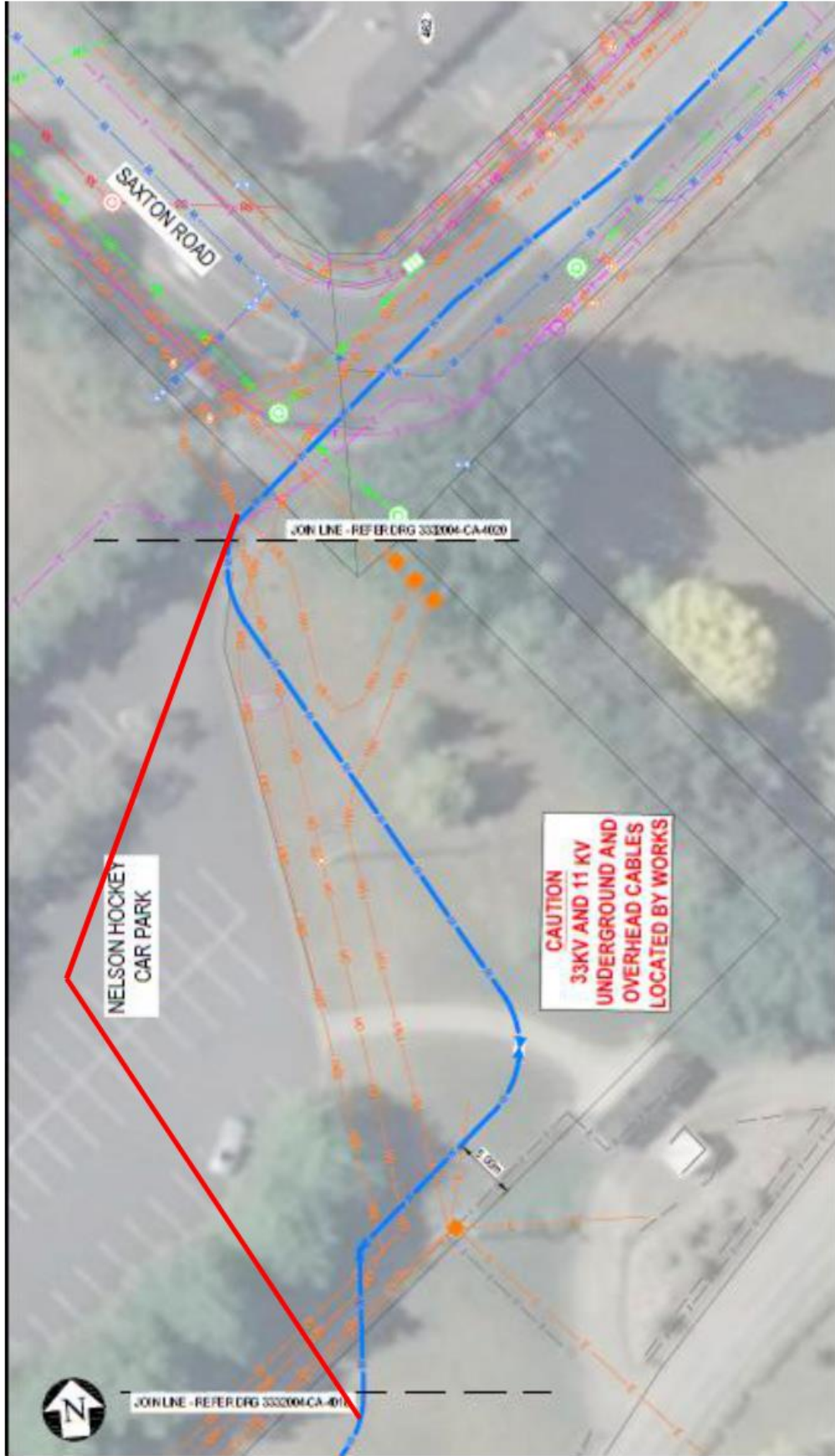
