# **Mask Parade Plan Approval**

# 1. Purpose of Report

- 1.1 To consider and approve the plan submitted by the Festivals Trust for the Mask Parade.
- 1.2 An extraordinary meeting of the Committee has been called to approve the delivery plan for reasons of timing; that is, the Trust needs to enter into financial commitments for the 2020 Mask Parade, in order to deliver the event in October 2020.

# 2. Summary

- 2.1 The Mask Parade and Carnivale is an integral part of the Arts Festival, and was due to take place in October 2020, but was cancelled due to the COVID-19 emergency.
- 2.2 When Alert Level One was reached, Council agreed to reinstate financial provision for the Mask Parade and Carnivale with a \$100,000 funding allocation in the Annual Plan 2020/21.
- 2.3 The Nelson Festivals Trust was asked to provide a delivery plan and budget for the Mask Parade and Carnivale for Committee approval. That plan is appended as Attachment 1.
- 2.4 Padma Naidu, Michaela Blackman and Brent Thawley from the Arts Festival Trust will be in attendance to present the plan and answer questions.

#### 3. Recommendation

# That the Community Services Committee

- 1. <u>Receives</u> the report Mask Parade Plan Approval (R18082) and its attachment (A2409656); and
- 2. <u>Approves</u> the delivery plan for the Mask Parade and Carnivale described in attachment 1 (A2409656) of report R18082 with a funding allocation of \$100,000.

# 4. Background

- 4.1 The Mask Parade and Carnivale is traditionally a showcase event for the Arts Festival, attracting an estimated 2,000 participants and an audience of 20,000. It is a free family event strongly supported by schools.
- 4.2 The arts festival programme was cancelled in March 2020 due to the COVID-19 emergency, the consequential difficulty with access for overseas performers, and anticipated restrictions on gatherings.
- 4.3 In June 2020 the government moved to Level One restrictions, making the delivery of a Mask Parade and Carnivale possible. Council consequently resolved via the Annual Plan:
  - <u>Approves</u> inclusion of a provision of \$100,000 for the Nelson Festivals Trust to deliver the Mask Parade and Carnivale.
- 4.4 The Arts Festival Trust has consequently developed a plan for Committee approval for the 2020 event (Attachment 1).

#### 5. Discussion

- 5.1 The Mask Parade is highly valued by the Nelson community and provides an opportunity to contribute to the social recovery of Nelson, and to help activate the CBD. The event will bring up to 22,000 participants and performers into the CBD on an otherwise quiet Friday night and stimulate hospitality venues in particular, with the additional patrons in town for the entertainment.
- 5.2 While the parade has a reduced timeframe to engage with schools, planned enhancements in 2020 include art mask displays across the CBD, more adult performers, increased spectator participation, live music, greater integration with hospitality providers and new routing.
- The Trust has developed a total budget for the Mask Parade of \$135,000. It has confirmed in the attached delivery plan that it will attempt to seek an additional \$35,000 from other sources and that, if this is not possible, the Trust will be able to scale back aspects of the event so that it can still proceed with the funding provided by Council.
- 5.4 A comparison with funding costs from previous years is difficult as Mask Parade and Carnivale funding has previously been included in the total Arts Festival funding, rather than a separate budget line.
- 5.5 Council officers are working closely with event organisers to ensure the Mask Parade links to related events (such as Matariki), achieves community outcomes and supports the economic revitalisation of the CBD.
- 5.6 It had been planned to bring this matter to the Committee at its next meeting on 30 July. However an urgent decision to approve the delivery

plan is required now because the Trust needs to start entering into financial commitments for the Mask Parade.

# Important considerations for decision making

# 1. Fit with Purpose of Local Government

This recommendation meets the purpose of local government by enabling delivery of services to achieve the social well-being goals of the community. Events are a recognised activity that contributes to the community social well-being.

# 2. Consistency with Community Outcomes and Council Policy

This event supports the Community Outcome, "Our communities have opportunities to celebrate and explore their heritage, identity and creativity."

#### 3. Risk

There is a low risk that the event may not proceed due to unforeseen circumstances such as a return to COVID-19 lockdown status or extreme weather events. There is a medium risk that school participation will be reduced due to the compressed planning time and shorter 2020 academic year, which is mitigated by a more diverse programme.

# 4. Financial impact

The 2020 event delivery is a 'one off' and will not set funding precedence as the Mask Parade will be incorporated into the Arts Festival programme in future years.

## 5. Degree of significance and level of engagement

This matter is of low significance because this project is a stand-alone event that is anticipated to receive widespread community support and participation. Therefore no engagement will occur on this report.

#### Mask Parade on the move!

The 2020 Mask Parade & Carnivale will represent the communities of Whakatū today and reflect our recent shared experience of Covid-19.

As a significant feature of Nelson's cultural landscape, this event will strengthen people's connection to place and community, celebrate the creativity and diversity that exists in Te Tau Ihu, and make the arts accessible and inclusive by bringing communities together as a whole.

The 2020 MP & C will be part of the Nga Toi Huatau - Community & Collaboration Programme.

Ngā Toi Huatau (The Seasonal Arts) is an NCC-initiated collaboration in which local festivals, art organisations, council departments, and individual artists contribute to a programme that runs from mid-July to the end of October,2020.

The programme will open with Matariki celebrations, and Nelson Arts Festival proposes the Mask Parade & Carnivale as the closing event on Friday October 30<sup>th</sup>.

#### Rethinking Mask Parade & Carnivale for 2020

Due to the disruptions of Covid-19, our delivery time for Mask Parade & Carnivale is compressed to 3–4 months (instead of the usual 6–7 months).

We see this as an opportunity to challenge the way in which the event has been delivered previously; to be more experimental and innovative, and to respond more authentically to today's cultural landscape.

**Our vision** is to begin with a gathering that collectively marks togetherness [a karakia, a piece of appropriate music....], moving into a mask parade that becomes a series of performances that take place over a shorter revised route, and seamlessly moves into a high-energy, engaging, colourful, and vibrant environment that continues into the evening.

We have started conversations with well-respected local Taonga pūoro musicians and they are liaising with mana whenua with-regard to the opening proposed.

This will be well communicated to public and schools so that the impact and purpose of this opening is not lost.

Our planning is based on the assumption that uptake for registrations in the 2020 Mask Parade will be lower than usual due to the compressed timeframe, especially with schools. However, planning will be flexible to accommodate larger numbers should this be the scenario.

We will increase the number of people engaging with local communities and schools compared to previous years to make up for the compressed time and feel that this will get schools and community groups on board at short notice.

The background to the parade element will be:

- High-quality street decorations (made by local artists and community groups) placed to
  decorate gathering and seating areas. We have a wealth of talented artists in the region that
  could take this on board.
- Lights festoons and balls of colour, including lighting on the cathedral and its gardens
- Flags street flags that are in place well in advance of the event
- Mass Mask Exhibition masks created by schools, community groups, artists, and art groups
  are prominently displayed in shop fronts, the street, the museum, art galleries, makeshift
  spaces, restaurants, and bars
- Live bands and DJs church steps/1903 site/Hardy Street/Kirby Lane/Church Lane using
  high quality local and national artists some possibilities, Rabbit Hole, Hopetoun Brown,
  Nico Nesma, Hipstamatics, all of whom have been well received here in Nelson, fall within
  our budget and currently show availability.
- Mask hawkers -100s of masks are given away to attendees to the event, who are
  encouraged to wear the mask and become part of an informal parade. These will be
  paper/card masks that have been extremely popular in the past.
  The masks are generally a memento people take home and there is little evidence (if any) of
  masks littering the streets at the end of the evening going by past experience.
- Roving performers in mask and costume entertaining people in food and dining areas and on the streets
- Different zones kids, youth, small markets, and food areas including Morrison Square

#### Marketing

As well as Council's online platform for Ngā Toi Huatau, we will promote the event via:

- Websites and social media of the 10+ partners in the Ngā Toi Huatau collaboration
- Websites and social media of all the venues taking part in the mass mask exhibition (already 20 venues on board)
- Nelson Arts Festival Website
- Nelson Arts Festival e-news
- Nelson Arts Festival Social Media: Facebook/Instagram/Snapchat/TikTok
- School newsletters and parent portals
- Radio
- · Uniquely Nelson with letters to businesses
- It'sOn
- Stuff/Nelson Mail
- NMIT
- Banner wrap ads across the weekly Nelson and Tasman papers

In addition, we will build a sense of anticipation for the Mask Parade & Carnivale by:

- Beginning the Mass Mask Exhibition a couple of weeks before the event
- Scheduling intriguing street activations in the days leading up to the MP & C

In previous years, the MP & C has been marketed as part of the wider Nelson Arts Festival. This year, the event will need a marketing boost to let people know that the MP & C is in fact going ahead after

all (despite being cancelled earlier), to convey that the well-known event has a new look, and to manage expectations around the new programme.

Our budget below reflects this in the marketing budget line.

#### Partnerships/Collaborations & Engagement

Loyalty to the Mask Parade & Carnivale is strong. Since the time that Council requested delivery of a MP & C once mass gatherings became permissible, our conversations with various community groups about their interest in participating in the event have been extremely positive.

We are confident that we will (if not already) get buy in from most of the groups below to take part in this year's MP & C:

- Multi-ethnic Groups with help from Nelson Multi-Cultural Council dancers and musicians from new migrant groups; Columbians, Koreans, Chinese, Indian etc
- · Performance groups such as Inside Out, Firebird Circus, Twisty Twins
- Individual street performers such as Paul Klass, Mulletman, Rob Bloor (and some from other areas of the country)
- Dance Academies Hip Hop, Rebecca Bignall, Nelson Dance, Effect Events
- Theatre Groups Nelson Am Dram, musical theatre, improv groups
- Community Groups; drumming, dancing, Tai Chi, Morris Dancers etc
- School and community bands & choirs, Nelson City Brass, Highland Pipes, school brass bands and orchestras, as well as musicians from NCMA and Voice Collective
- Arts organisations such as Community Art Works, The Refinery Artspace & Arts Council Nelson
- School kapahaka and other performance groups

#### Funding requested:

When planning for the 2020 MP & C earlier this year [pre Covid], we budgeted to include a mass spectacle choreographed by a professional mass movement choreographer, and for professional mask performers to take part in the parade which took the budget \$135,000.

Choreography and professional performers working with schools and community groups as well as a mass spectacle of some form is something we would still like to do.

We are already in conversation with local musicians and school groups regarding a mass choir and musical street performance (in mask) comprising of at least 100 people (school children and adults).

We appreciate that Council has allocated \$100,000 towards the Mask Parade & Carnivale therefore we will attempt to source the remaining \$35,000 from elsewhere.

If we are <u>not</u> successful in sourcing the additional \$35,000 form elsewhere, we will make cost savings (marketing, street dressage, entertainment & roving as well as contractors ) and deliver a Mask Parade & Carnivale to the budget of \$100,000 allocated by Council.

It should be noted that our planning needs to begin now. Planning cannot be left until the end of July when Council confirms these funds (30<sup>th</sup> July 2020).

Our investment in planning prior to Council approval is <u>estimated at \$30K</u>, which includes contractor fees, consent fees, and deposits on infrastructure items and deposit to artists.

We would appreciate some reassurance <u>before July</u> (when planning will commence) regarding reimbursement of any such cost if for any reason Council decides not to proceed with the additional funding.
