There is an alternative

A2751881

There is no question that change is needed

- 3 waters are run by Councils as an unregulated monopoly
- Monopolies = high prices, poor service and underinvestment in assets. NCC is no different.
- The travesty that is the Lee Valley dam almost certainly would not have happened if there was a regional water authority in place.
- Councils lack independence. The disgraceful Drought Security report demonstrated that NCC staff are not politically impartial. Even the CEO report on 3 waters lacks impartiality.
- Councils are conflicted when it comes to regulating. This was exemplified by NCC regulatory staff issuing a licence to pollute to a fictional creation – NRSBU - which has no employees, no bank account, no legal personality. The consent might as well have been issued to Felix the Cat! No-one can be held to account for breaches of consent conditions when the consent is held by a fictional creation.

The proposed model is not the “solution”


- The purported savings are fantastical and have been comprehensively discredited (Castalia and others)
- The geographical split is all about tribal politics and nothing to do with regional efficiencies
- Scale of economy doesn't exist in a country as geographically separated as NZ. How does the Top of the South get scale of economies with the rest of Entity C on the other side of Cook Strait?
- NCC will become an irrelevancy in Entity C – out of sight and out of mind. The provinces never benefit from centralisation – we are cut out of the deal stream and we are insignificant from an electoral point of view.
- The loss of direct control, local identity and responsiveness is an unacceptable price to pay for the fictional benefits
- The proposed governance is absurd - a board to appoint a board that will select a board! Lots of jobs for old political hacks though.

There is a far better alternative that demonstrably works




- 29 Electricity Network Companies in NZ
- Have been highly regulated for years
- They perform very well. Very few causes for complaint from end users
- Assets mostly well maintained
- Never any problem coping with or funding expansion
- Good local presence and local responsiveness
- Adapted to local conditions and customer needs
- Mix of ownership models – CCOs, trusts, private, NZX listed.
- High degree of co-operation and sharing of resources between network companies especially in times of disaster
- Well served by industry associations
- Deliver value for money


**Costs to customers show there are no obvious economies of scale.
Differences in cost to customer are primarily due to low population density
and/or remote location, not scale of the enterprise**

The Auckland Supercity amalgamation is a salutary lesson

The Supercity amalgamation has undoubtedly dealt with the issues of regional disunity and fragmentation **but**


- Auckland has 2nd highest rates in NZ - \$1000 p.a. higher than the nationwide average
- 2nd highest debt at \$29,611 per household and increasing by the day
- 2,831 Council staff paid more than \$100,000 pa
- 86 staff earning more than \$250,000 pa
- 234 Communications staff costing \$45 million pa
- Each household now paying \$830 per annum in interest costs on debt alone.
- Total staff numbers have increased
 - Legacy Councils and CCOs 9,430 FTEs on amalgamation
 - 2018/2019 figures for Supercity and CCOs 10,806 FTEs. **Where are the efficiencies?**

And of course Watercare has been a great success



“Watercare is under the gun. A predictable drought mishandled, two critical reports in as many months, Auckland councillors fuming after being handed a last-minute unexpected \$44 million budget expense in a Covid year.”

More evidence that size and supposed economies of scale don't stack up (Tatua is a fraction of the size of Fonterra)



Final Observations

- The proposed letter to the Minister is deceitful because it implies there has been a lot of engagement with the community on this matter when there hasn't.
- It is completely fallacious to “note” Morrison Low’s advice on the accuracy of the information provided to Council in June and July 2021 as a result of the Request for Information and Water Industry Commission for Scotland modelling processes”. The Morrison Low report contains many qualifications about the veracity of the WICS modelling. In fact the resolution should note the “inaccuracy” of the information.
- Acquiescence is acceptance. Kicking the can down the road is not an option. Council needs to make it very clear to the Minister that the current proposal is a non-starter for NCC.
- This is not a decision of “low to medium significance”. It is of vital importance.
- Placing this item at the end of a very long Agenda is a dirty trick and just a continuation of the game-playing; one-sided information disclosure and the manipulation that we have seen through this whole exercise.
- It must be very demoralising for staff to work for a CEO who doesn't think they can achieve any efficiencies at all in the next 20 years but thinks that a centralised bureaucracy can achieve 50% efficiencies. How insulting.

Maitahi Bayview - Plan Change 28

Introduction

- John Maassen. I will address you briefly on the legal aspects of your decision and state why the time has come to commence the plan change process using the RMA, Schedule 1 pathway.
- Hemi Toia for Ngati Koata will address you on the aspirations of manawhenua and the other Plan Change 28 partners for community engagement through a structured strategic planning process.

Maitahi Bayview - Plan Change 28

A gateway decision

- The decision the Council is making today is a ‘gateway’ decision i.e. a decision that opens or closes the door to a statutory process. It is not a decision to decide an outcome.
- The statutory process is open, transparent and allows for full public participation and debate so that the merits of the Plan Change may be tested by evidence and evaluation.
- The Plan Change proponents have a right of appeal to the Environment Court if you refuse the application to accept the Plan Change. The Council is a local authority managing high housing needs. If you refuse to accept the application then the Council’s ability to perform its legal duty under the National Policy Statement on Urban Development Capacity to act *responsively* to plan changes that enhance supply of residential land will be under intense scrutiny by the Environment Court.

Maitahi Bayview - Plan Change 28

The community need

- The Nelson City Council has a statutory responsibility to provide its citizens with what Policy 1 of the National Policy Statement on Urban Development Capacity calls a “well-functioning urban environment” .
- That term includes (as defined) *meeting the needs, in terms of type, price, and location, of different households; and enable Maori to express their customs, traditions and norms.*
- The Plan Change proponents consider that the Plan Change is part of the strategic planning solution for Nelson to address a self-evident dysfunction in Nelson’s urban fabric. That dysfunction is revealed by an affordability and supply crisis for the many people wishing to form households and live close to and have the benefits of the City.

Maitahi Bayview - Plan Change 28

The benefits of great design

- Plan Change 28 represents an opportunity to enable households to live close to the CBD and to house tangata whenua next to ancestral land.
- An opportunity to protect as open space some key landscape features of Nelson.
- An opportunity to set aside for future generations significant areas as regenerating indigenous vegetation.
- An opportunity to add to the public recreation portfolio by open space, tracks and cycleways.
- An opportunity for transport connectivity including an alternative road access to Nelson to improve public safety thereby enhancing regional hazard resilience.

Maitahi Bayview - Plan Change 28

An evolution not a revolution

- Plan Change 28 did not ‘fall out of the sky’.
- In the 1980’s the Council controlled the forming of the road called Ralphine Way opposite Waahi Takaro Reserve which leads to the Site. It was formed (and presumably the oversizing paid for) by the community so the road could perform not just as a small *cul de sac* but as a connector in the network as wide as Maitai Valley Road.

Maitahi Bayview - Plan Change 28

The statutory criteria.

- But the merits of the Plan Change are not up for debate here and now.
- What is up for consideration is whether there is any statutory basis to declare Plan Change 28 unworthy of public debate and examination on its merits according to law through the statutory process designed for strategic planning assessment.
- To refuse the application, the Council has to establish on rational grounds that one of a few and narrow statutory criteria is met. For example, the Plan Change is “frivolous” i.e. has no serious purpose.
- The advice you have from Nelson City’s officers and consultant’s is clear and correct. It is a straight-forward decision.

Maitahi Bayview - Plan Change 28

Looking forward

- The Proponents of the Plan Change do not claim at this early stage that Plan Change 28 is already a perfect plan for the Kaka Valley and environs. But they do claim it is a good plan. It is well conceived and is the product of a team's effort using mostly local and some national experts. It is well-founded on a combination of land resource use, management and protection and riparian enhancement. It is informed by and achieves according to manawhenua, matauranga Māori and therefore achieves the umbrella freshwater concept of Te Mana o te Wai.
- The Proponents will engage in the Schedule 1 process with an open mind and a willingness to consider constructive suggestions for refinement of the Plan Change from people of goodwill who are able and willing to debate the issues according to law using evidence-based analysis.

Maitahi Bayview - Plan Change 28

Looking forward

- Let an intelligent *korero* begin! Allowing that *korero* is the most appropriate and reasonable use of your mandate as representatives of the community to ensure societal debates are considered according to the law and evidence.



Private plan change requests

Overview


- RMA dictates PPC process
- Council has 4 options – accept, adopt, reject or convert
- Clause 25 is not full merits decision – that comes later
- It is a determination the PPC can continue to be processed
- High Court describes it as a ‘coarse filter’
- Limited ability to prevent further consideration (*Malory*):
“...unless one of the limited rejection grounds in clause 25(4) exists, the request must proceed to public notification, submissions, and a hearing in accordance with the well-established procedures of the Act”



Private plan change requests

Accepting/adopting under clause 25


- Accept – it proceeds as a PPC
- Adopt – it proceeds as a Council initiated PC
- If accept:
 - Goes through usual public notice/hearing process
 - Does not determine ultimate outcome on PPC
 - Does not equal agreement with PPC contents:
 - “...Clause 25 was intended to constitute a threshold test for adopting or accepting the request in whole or part. We agree that it is not the intent of Clause 25 that the Council necessarily agree with the contents of the plan change request”
 - Allows the merits of the PPC to be fully assessed through evidence and submissions




Private plan change requests

Rejecting under clause 25

- Constrained to five specific grounds
- Relevance of merits significantly constrained and are considered later (*Kerikeri Falls*):
 - “...the relevance of the merits is significantly constrained when the local authority is considering whether to reject a Request.
...the merits of the proposal arises for consideration at a later stage, under the clause 26 procedures”
- ‘Sound resource management practice’:
 - Relates to the purpose and principles of RMA
 - If clearly does not accord with those - can be rejected
- Specific effects issues - complex issues - will be fully assessed in substantive decision - not part of clause 25 decision

NELSON CITY COUNCIL'S RESPONSE TO GOVERNMENT'S PROPOSED THREE WATERS REFORM

I am writing on behalf of Nelson City's elected members to reflect Nelson City Council's (NCC) decision to respond to the Government on your proposed Three Waters Reform programme.

Since the Government announced additional detail on the proposed Three Waters Reform programme at the Local Government New Zealand (LGNZ) Conference, NCC has been reviewing and analysing the proposal to understand the Government's national case for change, the implications for Nelson City's ratepayers and the changing environment of providing three water services to our community.

Thank you for providing us with an opportunity to give our feedback on the proposal.

As part of our due diligence, we commissioned Morrison Low to review the Water Industry Commission for Scotland's (WICS) analysis of the dashboard information for Nelson City. While this analysis highlighted some differences due to the assumptions used, the main conclusion was that the WICS dashboards illustrated the 'right direction' in terms of costs for provision of water services in the future.

NCC had two elected member workshops, on 31 August and 9 September this year, with Morrison Low and LGNZ presenting their analysis. These workshops were recorded and made publicly available to our community. These workshops focused on the financial information, proposed governance structure, community representation and implications for NCC and the community.

Additionally, NCC held two webinar public meetings via Zoom (due to COVID-19 Alert Level restrictions) on 14 and 16 September 2021. The webinars were an opportunity to share information about the proposal and for members of the public to ask questions. They were recorded and made publicly available.

NCC's response is informed by the elected member workshops, public meetings and correspondence received from the public.



Item 13.1: Three Waters Reform Update - Amendment: Attachment 1

On 23 September 2021 Council resolved to respond to the Government with the questions and issues set out in the attachment to this letter. It would be helpful for these matters to be clarified publicly prior to Cabinet discussing the next stage of the reform.

NCC has concerns about the governance model. Additionally, we have concerns that the proposal could potentially increase the risk of future privatisation of three water assets. NCC strongly support the measures that reduce, or better still, eliminate the risk of privatisation. More details on these, and other issues, are provided in Attachment 1.

The proposed boundary between Entity C and Entity D is a cause of concern for both Marlborough and Tasman District Councils, as it could mean their districts are split between the two entities. Both Marlborough and Tasman have expressed a preference that their districts are not split by these reforms. NCC supports this view.

The reforms have been extremely challenging for our communities to assess and understand, and this has caused significant anxiety. The public information campaign has not met the needs of our community, as they have struggled to access clear and meaningful information to help them understand the issues. If the Government decides to proceed further with the Three Waters Reform, then there needs to be a significant improvement in the public information campaign.

We remain concerned that the public will not have an opportunity to provide meaningful feedback on the proposal. We look forward to the Government announcing the next steps in the reform programme, including how you will ensure there will be adequate consultation with the community.

Attachment 1: Nelson City Council: Questions and Issues.

Environmental standards and climate adaptation

- How will the Government ensure that the Water Service Entities plan and deliver resilient water services, alongside the efficiency gains as proposed? Resilient water services are just as important as efficiency gains.
- Will the Government place obligations on the Water Service Entities to plan for, and deliver, enhancements and restoration to our environment? This includes, but is not limited to, stormwater and wastewater discharges and restoration of our freshwater ecosystems alongside providing high quality drinking water.

Support Package

- What are the conditions attached to this package? What is the rationale for linking the funding to community wellbeing, climate change and housing? Does this include timeframes during which the package will need to be spent?
- Is the Government willing to negotiate an increase in quantum for the 'better off' package or a greater share coming from the Crown?
- When will more details on the 'no worse off' package be released?

Governance Structure and representation

- The structure, including the Regional Representative Group, is too convoluted, with councils too far removed from the entity. NCC wants to see this aspect of the reform addressed to achieve stronger accountability to councils, while still ensuring balance sheet separation.
- The Statement of Intent process is too opaque, and councils need more influence. These are critical documents of influence that directly impact the placemaking role of local government.
- How will the Regional Representative Group be established and how will appointments be made?
- Will social procurement be factored into the new entity? If so, would this include the living wage, non-commercial board fees, gender equity and contracted local services?
- Why isn't a cooperative model being considered?
- How can the Government ensure that privatisation will not occur in the long-term, noting a future Parliament's ability to amend the legislation?
- How will the Government ensure that the levels of debt of the water service entities will remain prudent, considering the councils will still be the owners of those entities?
- How will iwi involvement in the Regional Representative Group be determined?
- What assurances can be given that existing staff, local contractors, and resources would be retained in the Nelson region? What options are being considered to increase resources based in the Nelson region to support the proposed Entity C?

Planning Integration

- Additional information is required on how planning integration between the water service entity and councils will operate to ensure efficiencies, prioritisation, and responsiveness to local issues and circumstances.
- Does the Government see a role for councils in the future planning and engagement with three waters alongside the new Water Service Entities? Will councils be remunerated for this role considering all three waters income will be going to the new entities? Or is this a future participation cost that will be passed to local government with no compensation or revenue stream? This same issue will apply to mana whenua and needs to be addressed.

- How will the provision of stormwater services operate? How will the planning and implementation of this be integrated between the councils and Water Service Entities? If Council is to continue to provide flood resilience how will this be integrated with the Water Service Entity?
- Local Government directly engages with local communities on three waters service levels and delivery. How will this occur with the Water Services Entities?
- How will the entities respond to economic development opportunities that happen out of the planning cycle?
- How will the entities respond to economic development opportunities that may not be of significance at entity level but are of significance at a local level?
- What guarantees or undertakings can be given to ensure that planned and anticipated investment in the three waters infrastructure in Nelson would not be compromised or delayed?

Transfer of assets/Financials

- Does the Government intend for Water Catchment Areas to be considered assets for transfer to the new entities - understanding that some of these are gazetted as reserves or serve dual purposes for both utility and recreation/conservation functions?
- Is the land underneath three water assets, such as land which contains pump stations, stormwater detention ponds, water supply dams, storage reservoirs, treatment plants considered part of the assets which are proposed to transfer to the new entities? If not, will these require property agreements with councils?
- How will the new entities be funded? What would this look like and will it include rating mechanisms?
- How would the proposed cross-subsidisation between various council areas operate? Accepting that there will be some net beneficiaries, how do we ensure that places like Nelson that have invested in three waters infrastructure are not penalised because other councils have not invested at the same level?

Economic Regulator

- How will the proposed regulator ensure that the efficiency gains promoted through the reforms are achieved?

Consultation Process

- The reform programme will coincide with the 2022 local body elections. Does the Government see any impact on these elections, and can councils make decisions which will bind a future council considering the reforms will be completed post the 2022 local elections?
- This is the Government's proposal and communication with the public on these reforms need to be led by the Government. When communicating with the public additional information needs to be provided about what the proposal means for them in terms of future water pricing, levels of service, and local consumer voice.
- There is significant public commentary around the need for consultation with the community, due to the significance of the reforms. Council has received feedback requesting a referendum, or full public consultation, prior to implementation of the reforms. We seek urgent clarity on the Government's next steps and intentions for consultation.
