## 1. Purpose of Report

1.1 To endorse His Worship the Mayor Hon Dr Smith's submission to the Thomas Cawthron Trust Amendment Bill.

### 2. Recommendation

Dear Chair and Members

#### **Thomas Cawthron Trust Amendment Bill**

I write to indicate my strong support as Mayor of Nelson for the above bill that strengthens and improves the Thomas Cawthron Trust Act 1924. I have been privileged to be a statutory trustee since 1996 as the MP for Nelson for 24 years and, more recently, as Nelson's Mayor. The bill is a natural evolution of Cawthron's strengthened governance as the Institute has grown in size and importance to Nelson and New Zealand.

#### **Background**

The Cawthron Institute is a very special part of New Zealand's science community and a gem for Nelson. It came about as a consequence of the generous bequest of Thomas Cawthron over 100 years ago. The Institute has grown strongly over the past 30 years as a consequence of the science reforms of the early 1990s that enabled independent research institutes to have access to public good science funds on similar terms to Crown Research Institutes and universities. It is particularly important for Nelson due to the city not having a university nor being a home or headquartered city of any of New Zealand's Crown Research Institutes. The Cawthron has developed a global reputation for its science in areas such as marine and freshwater ecology and particularly in the applied sciences associated with aquaculture.

#### **Governance Structure**

The growth of the Cawthron Institute led the trustees in the early 2000s to establish a separate board of directors. This model was designed to parallel the structure of a CRI with the Trust providing the equivalent role of the Crown as the owner, represented by Cabinet and a Minister, but the governance role resting with the directors. This approach was formalised by High Court orders in 2003 but it is appropriate that these be transferred into an updated Act. The Bill provides certainty for both the trustees and directors of their roles.

#### **Statutory Trustees**

The Bill proposes to extend the statutory trustees from being the Bishop of Nelson, the MP for Nelson and the Mayors of Nelson and Tasman to include an iwi representative. This proposal was put forward at the time of the Te Tauihu treaty settlements, but it was not an appropriate change then as Cawthron is not a Crown entity. I subsequently proposed the change as a local MP and it was warmly embraced by all trustees. It is a variation from the intent in

Thomas Cawthron's will but noting the inclusion of the Anglican Bishop of Nelson as a statutory trustee, it is not necessary for them to be elected by the general public. The inclusion of a Te Tauihu representative on the trust is good for the Cawthron in recognising the role of mana whenua and building a stronger connection between Māoridom and science.

#### **Trustees Remuneration**

The Bill as drafted makes explicit that trustees may be paid for their services including for any reimbursements for necessary and reasonable out-of-pocket expenses. It correctly differentiates between trustees who "may" be remunerated and directors who "must" be paid. I am supportive of the clarification in Clause 17 of the Bill but I do not think it is appropriate that either Mayors or MPs, who receive payment as determined by the Remuneration Authority, should receive any additional payment for a role that arises directly as a consequence of their office holding. It might be possible for all trustees to be remunerated and then for these three to donate it back but this is messy, adding compliance and tax issues. It is better to be explicit that remuneration (beyond reimbursement for out-of-pocket expenses) is not intended for these trustees.

I submit that a further clause be added to make plain that should the Trust opt to remunerate trustees, it should not apply to trustees already remunerated for their role. My concern is that without explicitly saying so, the implication is that all or none of the members of the Trust Board be reimbursed for discharging their functions under the Act. Proposed new Clause 17 (1) (c): "There shall be no reimbursement under (b) for members of the Trust Board who are the Mayor of Nelson City, the Mayor of Tasman District or the Member of Parliament for the Electoral District of Nelson."

#### Conclusion

I hope the committee will see fit to support this amendment bill that is important to ensuring the Cawthron Institute continues to contribute to Nelson and New Zealand science for at least another century. I would welcome the opportunity to make an oral submission.
