## 5. Annual Report Adoption

Group Manager Community Services, Andrew White provided an update on the Community Services Group's performance, budget and library services. He answered questions on timeframes for the Marina Project, lifts and operability, boat ramp and enforcement levels of rules, reforestation management, event strategy updates, parks and recreation service levels, playground policy, vandalism statistics, aquatic facilities, carried forwards budget and CPI increases in budgets, cemetery facility upgrade, consultation process and community engagement on Stoke Hall and accessibility strategy updates.

The meeting was adjourned from 11.49a.m. until 12.50p.m. at which time His Worship the Mayor Hon Dr Smith left the meeting and Deputy Mayor O'Neill-Stevens assumed the Chair.

Group Manager Infrastructure, Alec Louverdis provided an update on the Infrastructure Group's highlights, financial performance, key performance measures, strategic direction, external government influences and key projects.
