Background information from Officers on 250 Haven Road for consideration

- 1.1 The building is utilised currently as a store for the Nelson City Council Festivals Team. The current agreement runs until 28 February 2018 but has a one month termination notice period to vacate if required.
- 1.2 Property records indicate the building has received limited lessee interest since Four Seasons vacated the building over 7 years ago.
- 1.3 The buildings internal layout is inflexible as it is a mix of different structures pieced together over time. Additionally its general condition is tired requiring further investment to create greater flexible space and improve the condition of the building.
- 1.4 The building, whilst not designated as earthquake prone, has a rating of only 24% of the new building standard (NBS). The cost to increase the buildings seismic rating up to 67% NBS is likely to be around the order of \$80,000.
- 1.5 Early Haven Precinct concept design work, currently underway, indicates that this area serving as a car park in the short to medium term would not be in conflict with longer term design. Traffic planning input would be required.
- 1.6 The likely cost to undertake the works requested in this Notice of Motion is in the order of \$160,000. Noting this is only a preliminary estimate and is dependent on extent of asbestos to be removed and level of making good to adjoining properties required. The asbestos and making good work is being assessed currently but it could see this figure rise to around \$220,000 plus GST.
- 1.7 The current Annual Plan and draft annual plan 2017/18 has no allocated budget for this work so it would be an unbudgeted cost.
- 1.8 There are no Capital Projects Team resources available between now and 30 June 2017 to project manage this additional project. If this project was to be deferred to the 2017/18 financial year, Capital Projects Team resources would need to be provided by deferring an existing programmed project of equal complexity.
- 1.9 Whilst preparation and enabling works, including obtaining a building consent, could potentially commence before 30 June

Standing Order 3.9.15 Revocation or alteration of resolutions

- (a) Such notice is to set out:
 - The resolution or part thereof which it is proposed to revoke or alter;
 - ii. The meeting date when it was passed; and
 - iii. The motion, if any, that is intended to be moved in substitution thereof.
- (b) Such notice is to be given to the Chief Executive at least 5 clear working days before the meeting at which it is proposed to consider such a motion and is to be signed by not less than one third of the members of the Local Authority, including vacancies.
- (c) The Chief Executive must then give members at least 2 clear working days notice in writing of the intended motion and of the meeting at which it is proposed to move such.

Standing Order 3.10.1 Notices of Motion to be in writing

Notices of motion must be in writing signed by the mover, stating the meeting at which it is proposed that the notice of motion be considered, and must be delivered to the Chief Executive at least 5 clear working days before such meeting.
