#### NZ Transport Agency News

#### Development of the 2018-21 National Land Transport Programme

- The National Land Transport Programme (NLTP) is produced every three years; preparation for the 2018-21 NLTP is already underway.
- Following the 2015-18 NLTP our key stakeholders identified several key areas for improvement, including a clearer outline of the wider strategic picture.
- In response to that feedback we started conversations with the sector to develop a shared Long Term Strategic View (LTSV).
- The Transport Agency has released a draft LTSV to Mayors, Regional Transport Committee Chairs, CEOs and officers for their feedback.
- This document is the first step in developing a shared view of the land transport system that will guide the development of the 2018-2021 NLTP.
- It has been created based on earlier discussions and feedback as well as incorporating current data and information to identify the key issues, opportunities, and potential solutions for a safe, connected and easy transport system.
- It is intended as a conversation starter as we work with our stakeholders and partners inviting your input and feedback to further refine the View together.
- We would like your thoughts, comments and feedback by the end of June 2017 if possible, so that the next iteration can be developed.
- We will present and discuss the draft LTSV in a workshop after the RTC meeting.

#### State Highway Investment Proposal

- We are engaging with local government on proposed activities in the State Highway Investment Proposal (SHIP) at the officer level, through existing advisory groups across all regions.
- We are underway with programming and national moderation of the proposed activities, which will be released in draft form in September 2017, for RTC consideration.

#### Electric Vehicle programme

- The Government's cross-agency Electric Vehicle (EV) Programme is well underway, making good progress towards increasing the number of EVs in New Zealand and reducing barriers to uptake.
   This work has included:
  - a trial of special EV lanes in Auckland
    - the Transport Agency's vision for nationwide public charging infrastructure
  - the newly gazetted road marking for EV charging facilities.

#### National Safety Campaigns

 The focus of our national advertising campaigns in May 2017 was on speed and distractions, and in June 2017 this shifted to a focus on drugs and alcohol.

#### International Safer Roads Conference

- The Transport Agency and partners helped to organise the 5<sup>th</sup> International Safer Roads Conference in Auckland in May 2017.
- The conference included discussion of international road maintenance best practice, new road surface innovations, footpath and cycleway surfacings, sustainability of resources, and targeted policies to help deliver a safer New Zealand.

#### Consultation on new approach to speed management

- Consultation on the Land Transport Rule: Setting of Speed Limits 2017 closed on Friday June 16.
- The draft rule will replace the current methodology developed in the 1960s with a new evidence-based approach to calculating speed limits on New Zealand roads.
- This approach, outlined in the new <u>Speed Management Guide</u>, encourages Road Controlling Authorities to target areas with the best opportunities to improve safety and efficiency.
- The draft rule also enables the setting of 110 kilometre per hour speed limits on selected state highway routes, gives local authorities new powers to quickly set new speed limits following an

emergency such as floods or earthquakes and introduces more flexible requirements around the placement of repeater speed limit signs.

#### 2. Events

#### NZ Transport Agency Board Regional Stakeholder meetings

- The Transport Agency Board is currently holding a series of stakeholder meetings around the country. The purpose of these events is for the Chief Executive, Fergus Gammie to share the Transport Agency's view of the future of transport and how the Transport Agency is transforming so it is ready to respond to the future and make the most of future opportunities for New Zealand.
- The event for the Top of the South was held on 2 June 2017.

#### 3. Delivery of the National Land Transport Programme

#### Nelson Southern Link Investigation

- The Programme Business Case for the investigation is currently being finalised. Once the PBC is
  finalised the Transport Agency will report the outcomes to the Transport Agency's Board and the
  Minister of Transport, and await next steps to be determined.
- The Transport Agency is working with the Nelson City Council to more fully understand expectations
  around growth and economic development, and the role that transport infrastructure plays in enabling
  that development.

#### Blenheim to Nelson State Highway 6 Investigation

- The Strategic Case identifies safety and resilience problems along the journey that could be treated.
- The Strategic Case is ready to be taken through the Transport Agency internal decision-making processes. We will provide an update at the meeting.

#### **Richmond Arterial Investigation**

- Development of the Network Operating Framework (NOF) is underway to determine how to efficiently manage the transport pressures from growth and land-use changes.
- The northern extent of the investigation is to Saxton Road in Nelson.
- The next step will involve stakeholder discussions to help determine levels of service desired levels of service (by mode and time).

#### Rai Saddle Realignment

- The project involves the construction of 1.3km of new two-lane State Highway 6, eliminating one highrisk curve and straightening four others.
- The initial stages of the project focused on site establishment work, ground stabilisation and tree removal, while the environmental management plan has ensured the work has a minimal effect on the local flora, fauna and waterways.
- More recently, an increased focus on earthworks, drainage and soil stabilisation has seen significant
  progress on site, with the project progressing well.
- Winter conditions make earthworks more challenging, however it is anticipated the new alignment will be ready for sealing towards the end of the year, with full completion scheduled for winter 2018.

#### Cycling Matters

- The Transport Agency is leading the delivery of the Maitai to Rocks Road cycle project (a Seaward Shared path and Improved On-Road Commuter Cycle Lanes). The project is being fully funded by the Urban Cyleways Fund and the indicative total cost is \$2 million. Construction is expected to occur between February and May 2018.
- On 18 May 2017 Nelson City Council has approved that the Transport Agency should lead the project delivery.
- The Transport Agency project team met with Nelson City Council officers on 7 June 2017 to discuss design and meet key personnel. A project control group including representatives from Nelson City Council has been established to oversee the delivery of the project.

#### Public Transport

• The Transport Agency is working with Nelson City Council in the preparation of their review of the public transport network and services.
