#### Post-Operative Spey Instructions

Rakah has been speyed today, which involved surgery to remove her ovaries and uterus, and therefore she needs care for some time. Unfortunately, dogs do not always understand that they must rest so we need you to assist in Rakah's recovery.

When you pick Rakah up from our hospital, she may be a little drowsy. This is quite normal following an anaesthetic and surgery. The drowsiness should subside over the next 12 - 24 hours. Please keep her inside and warm tonight. There may be some discomfort, so Rakah should not be expected to be completely normal for a few days. Please offer Rakah only small amounts of food and water tonight. From tomorrow morning, she can receive food and water as normal.

It is very important that Rakah **does not lick the surgical site** as this can introduce infection and also open the wound. Please monitor the incision for any signs of redness, swelling or discharge; and if any of these are identified please contact us immediately. We recommend using an **Elizabethan collar** to stop them from licking.

Restrict her **exercise** until her suture removal so that she has time to heal internally and does not put tension on her sutures. Avoid jumping, running, playing, steps and going for walks. Keep her on a leash when outside if she is very bouncy or active.

Rakah has intradermal (dissolving) sutures, we would still like to see her in 10 days time to check the wound has healed nicely.

Generally, there are very few complications following this operation, however, there are some signs to watch out for that may indicate a problem. If you notice any of these signs please contact us immediately:

- -Dull and listless especially (especially after the first 24 hours)
- -Excessive redness or irritation around the suture line
- -Swelling or lumpiness around the suture
- -Discharge or odour from the wound or reproductive organs
- -Vomiting, diarrhea, inappetence or blood in the stool
- -Chewing at sutures
- -Urinary incontinence (leaking of urine)
- -No stools for more than 2 days after coming home

Rakah has had pain relief that lasts for 24 hours and has been prescribed some oral pain relief for the next few days. Please give the prescribed medication as directed and feed Rakah normally throughout this time.

#### Medications - see label for dose instructions:

**Meloxicam Oral -** Give contents of one syringe (1.7ml) orally ONCE a day WITH food. Start on Wednesday morning. Stop if there are any signs of gastrointestinal upset, and contact us.

Recheck due: Please book at reception, there is normally no charge for this appointment.

-10 days: To check the surgical site. Alternatively you can email us a photo of Rakah's wound in 10 days time to petcare@victoryvets.co.nz

Spayed dogs need about 10-30% less food than entire dogs. It is important to reduce Rakah's food intake to avoid her becoming overweight, and more prone to arthritis and diabetes.

# Street naming application - 3B Hill Street

## 1. Purpose of Report

1.1 To approve or decline an application for the names of "Ara Tama Ariki", "Ara Ngāti Koata", "Ara Te Ātiawa", "Ara Ngā Hekenga" and "Ngāti Rārua Street" for the roads within the subdivision development at 3B Hill Street shown on the attached scheme plan (Attachment 1).

# 2. Summary

2.1 All of the names proposed for the subdivision meet the criteria of the Road Naming Guidelines.

#### 3. Recommendation

#### That the Hearings Panel - Other

- 1. <u>Receives</u> the report Street naming application 3B Hill Street (R19225) and its attachment (A2439164); and
- Approves the names of "Ara Tama Ariki",
   "Ara Ngāti Koata", "Ara Te Ātiawa", "Ara
   Ngā Hekenga" and "Ngāti Rārua Street" for
   the roads as shown on Attachment 1 of
   report R19225 (A2439164).

## 4. Background

- 4.1 The Council has the authority to name roads, pursuant to Section 319(j) of the Local Government Act 1974. Each proposed road name is assessed according to the criteria in the Road Naming Guidelines, as follows:
  - a) The name should not be the same as or similar to any other street in the Nelson and Tasman Regions.
  - b) Where appropriate, due regard should be given to historical associations within the City.

#### Item 2.1.1: Street naming application - 3B Hill Street

- c) Where possible, the name should be consistent with other names in the area, or consistent with a theme in the area/subdivision.
- d) The name should not be likely to give offence.
- e) The name should not be commercially based.
- f) The length of the name should be appropriate to the length of the street (i.e. short names for short streets - for mapping purposes).
- g) The name should not be likely to cause semantic difficulties, i.e. spelling, pronunciation, or general understanding.
- h) As a general rule, the proposed name should not be that of a living person, except in exceptional circumstances.
- 4.2 LINZ has advised that it is incorporating the use of "Ara" or "Te Ara" as road types in conjunction with Māori road names and there are several roads using this format including in Waikanae and Hastings. Road names using these road types are still checked against current criteria to ensure there is no duplication or similarities that could cause confusion or location problems.
- 4.3 On 5 August 2020 the Hearings Panel Other considered "Ara Ngāti Tama", "Ara Ngāti Koata", "Ara Te Ātiawa" and "Ara Ngā Hekenga" for street names within the subdivision development at 3B Hill Street. Officers identified Ara Ngāti Tama was similar to the existing Ngatitama Street and recommended Ara Kaitangata be approved instead of Ara Ngāti Tama. The alternative name was provided by the applicant prior to the hearing.
- 4.4 At the Hearing the applicant, Wakatū Incorporation, informed the Hearings Panel of the reasons behind the street name proposal and suggested "Ara Tama Ariki" be the alternative name to Ara Ngāti Tama. They also suggested the extension of Ngāti Rārua Street be named Ara Ngāti Rārua to be consistent with the other proposed names.
- 4.5 The Hearings Panel Other resolved on 5 August:

That the Hearings Panel - Other

- 1. <u>Receives</u> the report Street naming application 3B Hill Street (R18094) and its attachment (A2396577); and
- Requests further advice from officers on the use of 'Ara Ngāti Tama or 'Ara Tama Ariki' as the alternative for the proposed name 'Ara Kaitangata' for the road shown in attachment 1 (A2396577) of Report R18094; and
- Requests further advice on the use of Ara Ngāti Rārua for the proposed continuation of Ngāti Rārua Street for the road shown in attachment 1 (A2396577) of Report R18094.

#### 5. Evaluation

- 5.1 Officers consider that criteria a) of the Road Naming Guidelines is not met for "Ara Ngāti Tama" as it is too similar to Ngatitama Street. While Ara is different to Street the main name Ngāti Tama sounds the same as Ngatitama. Ngatitama Street is in the Nelson South suburb and Ara Ngāti Tama will likely be given the Richmond postcode. However, the use of suburb names in the Nelson Richmond area is not as common as in larger centres.
- 5.2 "Ara Tama Ariki" was suggested by the Chief Executive of Ngāti Tama as Tama Ariki was the name of the chief navigator on the Tokomaru waka that Ngāti Tama whakapapas back to. There are no similar names within the Nelson and Tasman regions. All other criteria are met for all proposed names.
- 5.3 LINZ was asked whether they would approve the extension of Ngāti Rārua Street as "Ara Ngāti Rārua" and they responded:
  - "Both names should not co-exist together, the potential for confusion is very high even if the numbering runs as if it is one road. The name needs to be one version or the other. At this point of the process, we would recommend naming and numbering the whole street as Ngāti Rārua Street. When or if consultation to adjust the name from Ngāti Rārua Street to Ara Ngāti Rārua takes place, adjustments can be made with minimal impact on the numbering for residents."
- 5.4 The road name blade for the existing part of Ngāti Rārua Street has been confirmed to include macrons already.
- 5.5 Council's Kaihautu has liaised with an accredited translator and advises the names would be more grammatically correct as follows:

Ara Te Ātiawa = Te Ara o Te Ātiawa

Ara Ngāti Koata = Te Ara o Ngāti Koata

Ara Ngāti Rārua = Te Ara o Ngāti Rārua

Ara Ngā Hekenga = Te Ara o Ngā Hekenga

Ara Tama Ariki = Te Ara o Tama Ariki

In addition an alternative to Te Ara o Tama Ariki was suggested "Te Ara o Ngārongoā" as Ngārongoā is the birth name of Hūria Mātenga. Hūria was part of a sea rescue of the crew from the brig *Delaware* caught in a storm and was thrown onto the rocks at the foot of the cliffs at Whakapuaka. Her paternal grandfather was Ngāti Tama leader Te Pūohoo-te-rangi, a renowned warrior.

5.6 The new format was checked with LINZ who would accept the names in this manner. The applicant prefers to keep the original format of "Ara" and not "Te Ara o..." for the purpose of a street name. The applicant also

states the majority of the Board of Ngāti Tama prefer "Ara Tama Ariki" and not "Ara Ngārongoā" or "Te Ara o Ngārongoā"

## 6. Options

- 6.1 The Hearings Panel has five options for the new streets:
  - a) To approve the names of "Ara Ngāti Tama", "Ara Ngāti Koata", "Ara Te Ātiawa" and "Ara Ngā Hekenga"; or
  - b) To approve the names of "Ara Tama Ariki", "Ara Ngāti Koata", "Ara Te Ātiawa" and "Ara Ngā Hekenga"; or
  - c) To approve the names of "Te Ara o Tama Ariki", "Te Ara o Ngāti Koata", "Te Ara o Te Ātiawa" and "Te Ara o Ngā Hekenga"; or
  - d) To approve the names of "Te Ara o Ngārongoā", "Te Ara o Ngāti Koata", "Te Ara o Te Ātiawa" and "Te Ara o Ngā Hekenga"; or
  - e) To decline some or all of the proposed names and to ask the applicant to submit alternative names.
- 6.2 Council officers recommend approving option b), the names of "Ara Tama Ariki", "Ara Ngāti Koata", "Ara Te Ātiawa" and "Ara Ngā Hekenga". Officers consider that "Ara Ngāti Tama" is too similar to the existing Ngatitama Street and would cause confusion and location problems for the community and emergency services. The "Ngārongoā" name is not supported by the applicant or by the majority of the Board of Ngāti Tama. The shorter names also reduce the complexity and risk of errors when using the extended names.
- 6.3 The Hearings Panel has two options for the naming of the extension of Ngāti Rārua Street:
  - a) To approve the name "Ngāti Rārua Street"; or
  - b) To request officers investigate the option to rename the existing Ngāti Rārua Street to "Ara Ngāti Rārua" or "Te Ara o Ngāti Rārua" so the whole street including the extension is named consistently with the new names identified above.
- Officers recommend approving option a) to keep the existing name of Ngāti Rārua Street for the extension. Option b) will involve consultation and a lengthy process that is unlikely to meet the needs of the developer in the short-term.

# Important considerations for decision making

## 1. Fit with Purpose of Local Government

The Council has the authority to name roads, pursuant to s 319(j) of the Local Government Act 1974.

## 2. Consistency with Community Outcomes and Council Policy

The decision in this report supports the community outcome that our Council provides leadership and fosters partnerships, a regional perspective and community engagement.

#### 3. Risk

The recommended names will avoid confusion but there is a high risk that Ara Ngāti Tama will cause confusion if this name is approved. Should this lead to problems in the future for emergency services this could lead to reputational damage for the Council.

# 4. Financial impact

No additional resources are required.

#### 5. Degree of significance and level of engagement

This matter is of low significance because there is no impact on any private person if the recommendation is approved. No consultation is required. If the Hearings Panel was considering approval of Ara Ngāti Tama then potentially all residents and owners of Ngatitama Street properties would be impacted. Similarly if the Hearings Panel was considering renaming Ngati Rarua Street to be Ara Ngāti Rārua then all residents and owners of Ngati Rarua Street properties would be impacted. Engagement with them, emergency services and postal services would be warranted before a decision is made.

## 6. Climate Impact

Not applicable for the naming of roads in an approved subdivision.

#### 7. Inclusion of Māori in the decision making process

The applicant, Wakatū Incorporation, has been liaising with the four iwi that comprise their membership (Ngāti Rārua, Ngāti Koata, Ngāti Tama and Te Ātiawa) for proposing street names for their development.

#### 1. Purpose of Report

1.1 To approve or decline an application for the names of "Ara o Tama Ariki", 
"Ara o Ngāti Koata", "Ara o Te Ātiawa", "Ara o Ngā Hekenga" and "Ngāti 
Rārua Street" for the roads within the subdivision development at 3B Hill 
Street.

# 2. Summary

2.1 All of the names proposed for the subdivision meet the criteria of the Road Naming Guidelines.

#### 3. Recommendation

#### That the Hearings Panel - Other

- <u>Receives</u> the report Street naming application - 3B Hill Street (R20311); and
- 2. <u>Approves</u> the names of "Ara o Tama Ariki", "Ara o Ngāti Koata", "Ara o Te Ātiawa", "Ara o Ngā Hekenga" and "Ngāti Rārua Street" for the roads as shown on Attachment 1 of report R19225 (A2439164).

# 4. Background

- 4.1 The Council has the authority to name roads, pursuant to Section 319(j) of the Local Government Act 1974. Each proposed road name is assessed according to the criteria in the Road Naming Guidelines.
- 4.2 LINZ has advised that it is incorporating the use of "Ara" or "Te Ara" as road types in conjunction with Māori road names and there are several roads using this format including in Waikanae and Hastings. Road names using these road types are still checked against current criteria to ensure there is no duplication or similarities that could cause confusion or location problems.

#### Item 0: Street naming application - 3B Hill Street

At the Hearing on 5 August the Panel requested further information from officers on proposed road names and the name for the continuation of the existing Ngāti Rārua Street. Officers provided a supplementary report for the Panel to consider on 3 September that also identified potential grammatical issues. The Panel requested officers to engage further with the Cultural Manager or Kaumatua of Wakatū Incorporation as to the correct expression of the proposed names. The Panel noted their preference for the names "Te Ara o Tama Ariki", "Te Ara o Ngāti Koata", "Te Ara o Te Ātiawa", "Te Ara o Ngā Hekenga" and "Ngāti Rārua Street".

#### 5. Evaluation

- 5.1 Officers have engaged with Wakatū Incorporation as requested and agree that "Ara o Tama Ariki", "Ara o Ngāti Koata", "Ara o Te Ātiawa" and "Ara o Ngā Hekenga" is the appropriate expression for street naming in te reo Māori.
- 5.2 LINZ has confirmed that the use of "Ara o" is acceptable in conjunction with the proposed Māori road names.

## 6. Options

- 6.1 The Hearings Panel has four options for the new streets:
  - a) To approve the names of "Ara Tama Ariki", "Ara Ngāti Koata", "Ara Te Ātiawa", "Ara Ngā Hekenga" and "Ngāti Rārua Street"; or
  - b) To approve the names of "Te Ara o Tama Ariki", "Te Ara o Ngāti Koata", "Te Ara o Te Ātiawa", "Te Ara o Ngā Hekenga" and "Ngāti Rārua Street"; or
  - c) To approve the names of "Ara o Tama Ariki", "Ara o Ngāti Koata", "Ara o Te Ātiawa", "Ara o Ngā Hekenga" and "Ngāti Rārua Street"; or
  - d) To decline some or all of the proposed names and to ask the applicant to submit alternative names.
- 6.2 Council officers recommend approving option c) as the names meet the criteria in the Road Naming Guidelines, are correctly expressed in te reo Māori and are not too long that could increase the risk of errors and naming issues for mapping.
